

# GIB<sup>®</sup> 90 YEARS CELEBRATION- TRADE PROMOTION TERMS AND CONDITIONS

The competition starts on 1<sup>st</sup> September 2017 and ends on 5pm 31<sup>st</sup> October 2017 (the Promotion Period).

1. The **grand prize** is 1 of 4 x \$5,000 (GST Inclusive) travel vouchers from Hello World Travel

The **total draw prize pool** comprises of the 4x \$5,000 travel vouchers, plus the following prizes supplied as gift vouchers:

- 10 x Apple gift vouchers valued at \$500 each
- 10 x Red Balloon Day Adventure gift vouchers valued at \$500 each
- 40 x Swannndri gift vouchers valued at \$150 each
- 40 x Icebreaker gift vouchers valued at \$150 each
- 55 x Visa Prezzy Cards valued at \$100 each
- 55 x Rebel Sport gift vouchers valued at \$100 each
- 60 x Noel Leeming gift vouchers valued at \$100 each
- 60 x Gourmet Direct gift meat vouchers valued at \$100 each

(Prize values are GST inclusive). The \$45,000 gift voucher prize pool will be equally split between two \$22,500 draws: one for September qualifying entries and one for October qualifying entries.

2. The promoter of the sales promotion scheme is Winstone Wallboards Limited (WWB), whose address is 37 – 41 Felix Street, Penrose, Auckland.
3. The GIB<sup>®</sup> 90 Year Celebration – TRADE PROMOTION (including its running and operation) is independent of all other GIB<sup>®</sup> branded promotional activity including The GIB<sup>®</sup> 90 Year Celebration – WEBSITE PROMOTION.
4. All trade account customers with participating GIB<sup>®</sup> product stockists (“GIB product” refers to all GIB<sup>®</sup> branded plasterboard and accessories) who purchase at least \$500 (excl. GST) of any GIB<sup>®</sup> products from those participating GIB<sup>®</sup> stockists in New Zealand during the Promotion Period will automatically be entered into the grand prize and monthly prize draw for the month the purchase was made. To qualify, purchases/orders must be entered and confirmed by the participating GIB<sup>®</sup> product stockist. Qualifying purchases/orders must be entered and confirmed through a single trade account with a participating GIB<sup>®</sup> stockist (i.e. multiple purchases through different trade accounts or with different merchants may not be combined).
  - Customers who purchase between 1<sup>st</sup> and 30<sup>th</sup> September 2017 will be entered into the grand prize draw and monthly prize draw for September.
  - Customers who purchase between 1<sup>st</sup> and 31<sup>st</sup> October 2017 will be entered into the grand prize draw and monthly prize draw for October.

Please note that entry validity is also subject to the timing requirements in clauses 7 and 8, relating to the time by which participating GIB<sup>®</sup> product stockists must notify Winstone Wallboards of entry details based on purchases on those stockists’ trade accounts.

5. This promotion is open to trade account customers only with participating GIB<sup>®</sup> product stockists. Entries are allocated to the trade account. By purchasing the required amount of GIB<sup>®</sup> branded plasterboard or accessories on your trade account, the trade account holder is automatically entered into the draws. There is no need to complete an entry form (unless requested to do so by the GIB<sup>®</sup> merchant stockist). Any prize won by a trade account holder will be allocated to the person / entity whose account it is, and any further allocation of the prize amongst partners or business owners will be the responsibility of the relevant person / entity. By participating in this promotion, you authorise participating GIB<sup>®</sup> product stockist to process entries and send details of entries to Winstone Wallboards in accordance with these terms.
6. You will receive one entry into the monthly prize draw for the month the purchase was made and one entry into the grand prize draw for every \$500 (excl. GST) spent on any GIB<sup>®</sup> branded

(on your trade account) during the Promotion Period, from participating GIB® product stockists in New Zealand.

7. There will be a total of two monthly prize pool draws, namely:
  - A draw will be done by Wednesday 11<sup>th</sup> of October for the September prize round (165 prizes drawn)
  - A draw will be done by Friday the 10<sup>th</sup> of November for the October prize round (165 prizes drawn)
  
- Note:** Although any one customer may qualify for multiple entries in any given month (September and/or October), a maximum of one gift voucher prize will be allocated per customer per month. Valid entries to the grand prize draw remain valid irrespective of an entrant winning a gift voucher.
  
8. The grand prize draw will be by Monday 13<sup>th</sup> of November and will be drawn from all valid grand prize draw entries over the two month promotional period.
9. Winners will be determined by a random draw carried out by an external auditing agency independent from Winstone Wallboards from all valid grand prize draw entries received during the Promotion Period.

Entries received by Winstone Wallboards from participating GIB® product stockists by email to [90years promo@gib.co.nz](mailto:90years promo@gib.co.nz) after the below dates/times will be ineligible for entry into the monthly gift voucher draws and final grand prize draw (unless otherwise stated below):
  - September monthly prize draw: Cut off for Winstone Wallboards to receive entries from stockists is 5pm Thursday 5<sup>th</sup> October.
  - October monthly and grand prize draws: Cut off for Winstone Wallboards to receive entries from stockists is 5pm Monday 6<sup>th</sup> November.
  
11. Within a single trade account, the \$500 (excl. GST) purchase of GIB® products is accumulative over the month (e.g. September or October 2017) and does not have to be on one invoice. There will be no carryover of any balances into the next qualifying month (i.e. in the event of the total purchases of GIB® branded s being less than \$500 (excl. GST)). Balances will not be rounded up.
12. The purchase of non-GIB® branded products do not qualify for the promotion (this includes GIB service charges such as extra labour delivery charges and refundable plasterboard pallet charges). Any returns / credits do not qualify for the promotion.
13. For the monthly prize draws, prize winners can only win one prize per month (i.e. customers who are drawn twice in a prize draw are only eligible to win the first prize drawn). Any subsequent prizes will be redrawn.
14. Monthly prize draw winners are also eligible to participate in the grand prize draw.
15. All entrants consent to their personal information being collected and stored by Winstone Wallboards for the purpose of this promotion. Should you be drawn as one of our winners, your details will be used to issue your prize to you. You will not be added to our database and Winstone Wallboards will not share your personal information with any third parties except as may be needed for the purpose of issuing the prize to you. You consent to receiving electronic communications from Winstone Wallboards in connection with the prize draw. As per clause 4, participating GIB® product stockists will notify Winstone Wallboards of entry details based on purchases on those stockists' trade accounts, including such information as necessary to facilitate entries and draw administration.
16. All entrants who win a prize agree to make themselves available for a photo session if required by Winstone Wallboards and acknowledge Winstone Wallboards has the right to use these publicity photos in any reasonable manner.
17. Five attempts will be made to contact the prize winners. If unsuccessful Winstone Wallboards reserves the right to select new prize winners and may continue to do so until the prize winner has been successfully contacted.
18. All monthly and grand prize winners will be required to present photo identification and authentication of trade account ownership in order to claim their prize.
19. The prizes must be taken as stated and cannot be deferred or exchanged or transferred. There will be no cash alternatives. Arrangements for delivery of the prizes will be made between Winstone Wallboards and the winner.

20. By accepting the prize, all winners grant Winstone Wallboards exclusive permission to use their names, characters, photographs, voices and likeness in connection with the promotion and waive any claims to compensation for such use.
21. Winstone Wallboards reserves the right to refuse awarding any prize to a person who Winstone Wallboards, in its sole discretion, determines has breached these terms and conditions or who did not validly qualify to enter the prize draw.

Winstone Wallboards reserves the right to request copies of sales transaction records of prize winners from the GIB stockist for the purpose of verifying the eligibility of the prize winners entries into the prize draws. Failure to provide these records upon Winstone Wallboards request will result in prizes being forfeit. Any forfeit prizes will be redrawn as per the process outlined in the competition terms and conditions.
23. In the event that any of the prizes become unavailable for reasons beyond Winstone Wallboards control, Winstone Wallboards may substitute a prize of equal or greater value.
24. The competition is open to New Zealand residents only. Overseas entries will not be considered.

29. As the administrator of this promotion, Winstone Wallboards reserves the right to cancel the promotion at any stage, if deemed necessary in its opinion, and if circumstances arise outside of its control.
