(a) The claimant must provide written proof of purchase and make a written claim either within 30 days after the defect would have become reasonably apparent or, if the defect was reasonably apparent prior to installation, then the claim must be made prior to installation;

(b) The project must be designed and constructed in strict compliance with all relevant provisions of the current New Zealand Building Code, and in compliance with other regulations and standards that apply to the project;

(c) This warranty does not apply where the product has been used in any manner not in accordance with the relevant Winstone Wallboards literature current at the time of installation and under normal conditions of dry internal use, nor the reuse of the product after its initial installation;

(d) Winstone Wallboards will not be liable where the specified GIB® branded components, design details and construction practices are not adhered to in accordance with the relevant GIB® systems literature;

(e) Subject to (d) all other products applied to or used in conjunction with GIB® products or systems must be applied or installed and maintained strictly in accordance with the relevant manufacturer's instructions and good trade practice;

(f) In the event of a breach of warranty, Winstone Wallboards will, at its option, (1) supply replacement product, (2) rectify the affected product or (3) pay for the cost of the replacement of the affected product. Winstone Wallboards will not be liable for any losses or damages arising as a result of the breach of warranty or the defective product or systems, other than as set out in this paragraph (f);

(g) Winstone Wallboards will not be liable for any claims, damages or defects arising from or in any way attributable to events outside of Winstone Wallboards' control, including but not limited to, poor workmanship, poor design or detailing, settlement or structural movement and/or movement of materials to which the product is attached, incorrect design of the structure, efflorescence or performance of paint/coatings applied to the product, water ingress, normal wear and tear, growth of mould, mildew, fungi, bacteria, or any organism on any product surface or product (whether on the exposed or unexposed surfaces), or acts of God (such as earthquakes, cyclones, floods or other severe weather conditions or unusual climatic conditions);

(h) All warranties, conditions, liabilities and obligations other than those specified in this warranty are excluded to the fullest extent allowed by law;

(i) If meeting a claim under this warranty involves recoating of GIB® products, there may be slight colour differences between the original and replacement GIB® products due to the effects of variations in materials over time;

(j) The statements in this warranty may be superceded at any time by Winstone Wallboards publishing a new warranty on its website, and in that case the new warranty will apply from that date (whether the product or system was purchased prior to or after that date).
